The intent of this agreement is to provide _____ (Guardian) with a female teacup poodle at a discount and for the Breeder/Owner _____ to have the dog participate in their breeding program while the Guardian agrees to provide a loving home, care and supervision of the dog as stated in this agreement. The Guardian agrees to pay \$000 to the Breeder/Owner in order to obtain the dog.

Both parties (Breeder and Guardians) agree to be legally bound by the following agreement:

Breeder's Responsibilities:

During the time the Breeder has possession of the dog, the Breeder shall:

- 1- The Breeder will take possession of the female dog at the appropriate time for breeding. The dog will stay with the Breeder for 6 weeks during the breeding process. Male dogs will stay with the Breeder for 2 days during the breeding process.
- 2- The Breeder will pay for all veterinary expenses as related to breed-related costs only (any health exams necessary for breeding, etc.).
- 3- While the dog is in the Breeder's possession the Breeder will follow the same feeding regime and daily routine that the Guardian follows.
- 4- The Breeder agrees to pay for any veterinary visits due to illness or injury while in Breeder's care. This includes severe diarrhea, loss of appetite, vomiting, etc. and pay for any veterinary visits due to illness or injury while in the Breeder's care.

Guardian's Responsibilities:

During the time the Guardians have possession of the dog, the Guardians shall:

- 1- The Guardian agrees to safely confine the dog by using a traditional fence restraining the dog by using a leash whenever outside of the Guardians home or yard, keeping the dog away from female dogs in order to avoid any accidental mating.
- 2- Provide appropriate care for the dog including providing food and water for the dog on a daily basis. Also provide appropriate time outside for potty breaks as needed. This includes keeping the dog well-groomed with necessary bathing/cleaning and haircuts to avoid matting.
- 3- Provide vet care as needed, including regular vaccinations and rabies vaccine, monthly flea, tick and heartworm medications. The Guardian must provide Breeder the dates of treatments & any vet care for Breeder own records.
- 4- Notify the Breeder at the first sign of illness or at time of injury and pay for any veterinary visits due to illness or injury while in the Guardians care. This includes severe diarrhea, loss of appetite, vomiting, etc. and pay for any veterinary visits due to illness or injury while in Guardians care.
- 5- Keep the dog away from male dog so that no accidental breeding takes place.

Death of Dog while in Guardian's Possession:

Should the dog die from natural causes that are not considered negligence (non-compliance of using a leash or not keeping the yard fence in good repair and gate closed) this Agreement shall terminate upon the happening of such occurrence and neither party shall have any further obligation to the other party.

Death of Dog while in the Breeder's Possession:

Should the dog die from natural or accidental causes that are not considered negligence (non-compliance of using a leash or not keeping the yard fence in good repair and gate closed) this Agreement shall terminate upon the happening of such occurrence and neither party shall have

any further obligation to the other party.

Transfer of Ownership:

After 3 years, from the start of this Agreement, the Breeder shall transfer ownership of the dog to the Guardian. The dog will retire from breeding. At that time, this contract will be null and void.

Return of Dog to Breeder:

During the term of this Agreement, the Guardian may return the dog to Breeder for any reason, at which time this Agreement shall terminate.

Immediate Payment to Breeder:

If prior to transfer of ownership from the Breeder to the Guardian, any of the following occurrences happen, the Guardians agree to pay the Breeder the sum of **\$000**:

- 1- Guardian, independently and without the expressed written consent of Breeder, has the dog spayed or neutered.
- 2- Guardian intentionally causes injury to the dog that prevents the dog from breeding or intentionally or out of negligence causes death of the dog.
- 3- Guardian leaves the city/state with the dog and fails to advise Breeder of any change in Guardian's address, or ceases communication with Breeder.
- 4- Guardian relocates and wants to receive full ownership of the dog prior to the first successful.

Non-Transferable

This Agreement shall not be transferred to another Breeder or Guardian in whole or in part without prior agreement.
